Backed by \$1M and preparing a \$4M round, Cognishine addresses the global shortage of adaptable therapy tools with a seasoned team and strong product-market fit.

Core Technology

Cognishine leverages generative Al, multi-language content adaptation, and proprietary content architecture to deliver therapy activities. Its scalable platform enables therapists to personalize care plans, and support diverse populations—from children to seniors—across languages and cultures, with minimal setup and strong clinical relevance.

Product Profile/Pipeline

Cognishine offers over 6,000 therapist-designed activities, including executive function, articulation, reading comprehension and more. Al-powered insights and session generators are in development.
